1. 72-Hour General Health Guarantee

Puppy is guaranteed to be in good health at time of sale. Buyer may have the puppy examined by a licensed veterinarian within 72 hours. If unfit, Buyer may return or keep the puppy. Seller may request a second opinion. Treatments before contacting Seller void guarantee.

2. 24-Month Hereditary & Genetic Guarantee

Puppy is guaranteed against hereditary/genetic defects for two years. Buyer may return puppy for replacement or keep puppy and receive an additional puppy. Conditions not covered include size, height, coat, color, parasites, viral infections after 72 hours, accidents, abuse, or neglect.

3. Breeding Status & Registration

Without breeding rights, puppy is sold with Limited Registration. Unauthorized breeding voids guarantee and results in a \$2,000 penalty.

4. Buyer Responsibilities

Buyer agrees to maintain proper nutrition, vaccinations, avoid public exposure until vaccinated, and keep puppy as a house pet.

5. Diet Requirements

Buyer agrees to feed Inukshuk 26/16 for 3 days. Sudden food changes void guarantee.

6. Photo Use Permission

Buyer authorizes Butterball Kennel to use puppy photos unless refused in writing.

7. Florida Statute 828.29 Acknowledgment

Buyer waives statutory alternatives and accepts this contract as sole remedy.

8. Non-Transferability

Contract becomes void if ownership transfers.

9. Return to Breeder / Lifetime Take-Back Policy

Butterball Kennel requires that if at any time the Buyer is unable or unwilling to keep the puppy, the puppy must be returned to Butterball Kennel. Under no circumstances is the puppy to be surrendered to a shelter, rescue, or third party without the prior consent of Butterball Kennel. Butterball Kennel's goal is to ensure the lifelong welfare of each puppy and, if necessary, to place the puppy into a suitable adoptive home at an appropriate time.

10. Buyer Declaration

No guarantees for show/breeding quality or appearance. No returns except for validated hereditary conditions.
